INITIAL ANNOUNCEMENT

CATALOG OF FEDERAL DOMESTIC ASSISTANCE: This program is listed in the Catalog of Federal Domestic Assistance under 10.500.

DATES: Applications must be received by close of business (COB) on July 27, 2009 (5:00 p.m. Eastern Time). Applications received after this deadline will normally not be considered for funding. Comments regarding this request for applications (RFA) are requested within six months from the issuance of this notice. Comments received after that date will be considered to the extent practicable.

STAKEHOLDER INPUT: The Cooperative State Research, Education, and Extension Service (CSREES) is requesting comments regarding this RFA from any interested party. These comments will be considered in the development of the next RFA for the program, if applicable, and will be used to meet the requirements of section 103(c)(2) of the Agricultural Research, Extension, and Education Reform Act of 1998 (7 U.S.C. 7613(c)(2)). This section requires the Secretary to solicit and consider input on a current RFA from persons who conduct or use agricultural research, education and extension for use in formulating future RFAs for competitive programs. Written stakeholder comments on this RFA should be submitted in accordance with the deadline set forth in the DATES portion of this Notice.

EXECUTIVE SUMMARY: CSREES announces the availability of grant funds and requests applications for the Children, Youth and Families at Risk Capacity Building Program for fiscal year (FY) 2009 to marshal resources of the Land-Grant and Cooperative Extension Systems so that, in collaboration with other organizations, they can build the capacity through professional development and best practice dissemination to increase the development and delivery of educational programs that equip limited resource families and youth who are at risk for not meeting basic human needs with the skills so they lead positive, productive, contributing lives. The amount available for support of this program in FY 2009 will be approximately \$400,000.

This notice identifies the objectives for Children, Youth and Families Capacity Building Program projects, the eligibility criteria for projects and applicants, and the application forms and associated instructions needed to apply for a Children, Youth, and Families Capacity

Building Program grant. CSREES additionally requests stakeholder input from any interested party for use in the development of the next RFA for this program.

PART I—FUNDING OPPORTUNITY DESCRIPTION

A. Legislative Authority and Background

Funding for CYFAR Capacity Building Program is authorized under section 3(d) of the Smith-Lever Act of May 8, 1914, as amended (7 U.S.C. 341, *et seq.*). Section 7403 of the Food, Conservation, and Energy Act (FCEA) of 2008 amends section 3(d) of the Smith-Lever Act of 1914 (7 U.S.C. 343(d)) in regards to eligibility. The eligibility to compete for CYFAR funding is broadened to include 1890 Land-Grant Colleges and Universities, including Tuskegee University and West Virginia State University. Eligibility is also provided to the University of the District of Columbia.

B. Purpose and Priorities

The mission of the CYFAR Program is to marshal resources of the Land-Grant and Cooperative Extension Systems so that, in collaboration with other organizations, they can develop and deliver educational programs that equip youth who are at risk for not meeting basic human needs with the skills they need to lead positive, productive, contributing lives. The CYFAR philosophy (<http://www.csrees.usda.gov/nea/family/cyfar/philosophy.html>) is the basis for Sustainable Community Projects.

The purpose of CYFAR Capacity Building Program funding is to build the capacity through professional development strategies and best practice dissemination for delivery of educational programs and quality comprehensive community-based programs for at-risk children, youth, and families supported by the Cooperative Extension System.

The CYFAR Capacity Building Program has two strategic objectives:

1. A collaborative, multi-university project to build capacity within the land-grant university and Cooperative Extension systems through professional development strategies for Children Youth and Families Education and Research Network (CYFERNet), CYFAR Sustainable Community Project (SCP) staff and CYFAR Liaisons which support the community educational programs for at-risk children, youth, and families population; and
2. A collaborative, multi-university project to provide applied research and best practices dissemination of programming efforts of the CYFAR program related to special audience needs for CYFAR SCP projects in partnership with federal collaborative IWGYF and present finding through a virtual summit.

Applications are being solicited for the CYFAR Capacity Building Program under the following areas:

CYFAR Capacity Building Program- Professional Development Strategies

A. Core Competencies for Working with CYFAR Audiences

- 1) Determine competencies for working with CYFAR audiences based upon the Professional Research Knowledge and Competency (PRK-C) <http://www.national4->

- hheadquarters.gov/comm/4h_prodev_sc.htm and the National 4-H Learning Priorities http://www.national4-hheadquarters.gov/comm/4h_prodev_tpd.htm;
- 2) Determine training needs for CYFAR community site staff and institution team members for each competency;
 - 3) Review present training materials;
 - 4) Develop training modules for competencies not covered by existing materials; and
 - 5) Develop certification programs with either Professional Development Unit (PDU) or Continuing Education Unit (CEU) approval.

B. CYFERNet and CYFAR Liaison Capacity Building Targeted Conference and Training - to enhance and build capacity for the CYFAR Liaisons and CYFERNet program editors, technology team and evaluation teams who provide their technical support to the Sustainable Community project site staff.

- 1) Host a conference and training for CYFAR Liaisons and CYFERNet program staff; technology and evaluation team members inclusive of current research-based and evidence-based practices in the areas of technology, evaluation, and programming;
- 2) Develop strategies for collaboratively building the three components, evaluation, technology and programming, of CYFERnet professional development projects; and
- 3) Provide support for CYFAR Liaisons to conduct specialized professional development trainings for CYFAR SCP projects relevant to under-served and/or new audiences as identified by current and relevant research related to poverty and economic stressors from Kids Count, <http://datacenter.kidscount.org/>.

CYFAR Capacity Building Programs – Best Practices Dissemination Strategies -To enhance the viability and sustainability with the federal collaborative on youth programs.

A. Federal Collaborative Partner Opportunities

- 1) Review the current issues surrounding evidence-based practices and programs;
- 2) Examine how Federal government agencies define evidence-based programs/practices and provide some recommendations on how to be consistent;
- 3) Identify promising/best practices and how to disseminate these;
- 4) Develop strategic partnership opportunities with the federal agency collaborative, Interagency Working Group on Youth Programs (IWGYP) with the coordinating website: <http://findyouthinfo.gov/>; and
- 5) Communicate and disseminate findings regarding evidence-based practices/programs and promising/best practices and recommendations through webinars, workshops, live discussions/meetings/conferences in partnership with the IWGYP.

B. Promote Relevant Topics with Expert Engaged Panelists via a Virtual Summit

- 1) Host a national virtual summit with experts from the Land-Grant Institutions to build capacity on such topics of poverty, working with specific targeted high-risk audiences as identified by current and relevant research related to poverty and economic stressors from Kids Count, <http://datacenter.kidscount.org/> e.g., African-American young males), and the expansion to audiences at risk such as Native American and Hispanic families/youth; and

- 2) Virtual summit includes the latest research as well as application of best practices. The summit would be recorded and archived. Stipends would be included for those serving on panels for the virtual summit.

C. Program Area Description

CYFAR Capacity Building Program encompasses two components. In FY 2009, each applicant may apply for one or both CYFAR Capacity Building Program component(s).

PART II—AWARD INFORMATION

A. Available Funding

There is no commitment by USDA to fund any particular application or to make a specific number of awards. Approximately \$200,000 will be available for each component to fund standard awards in FY 2009.

B. Types of Applications

In FY 2009, all applications submitted to the CYFAR Capacity Building Program should be new applications. This is a project application that has not been previously submitted to the CYFAR Capacity Building Program. All new applications will be reviewed competitively using the selection process and evaluation criteria described in Part V—Application Review Requirements.

C. Project Types

CSREES is seeking applications from institutions that can demonstrate their ability to develop institutional capacity to develop and deliver programs for at-risk children, youth, and families and have a proven track record of capacity building programming efforts. Applications should be submitted for a 1-year period.

PART III—ELIGIBILITY INFORMATION

A. Eligible Applicants

Applications may be submitted by Cooperative Extension at 1890 Land-Grant Institutions, including Tuskegee University and West Virginia State University, at 1862 Land-Grant Colleges and Universities, and the University of the District of Columbia. An applicant's failure to meet an eligibility criterion by the time of an application deadline will preclude CSREES from reviewing their application or making an award.

Award recipients may subcontract to organizations not eligible to apply provided such organizations are necessary for the conduct of the project.

B. Cost Sharing or Matching

CSREES does not require matching or cost sharing support for this program, and matching resources will not be factored into the review process as evaluation criteria.

PART IV—APPLICATION AND SUBMISSION INFORMATION

A. Electronic Application Package

Only electronic applications may be submitted via Grants.gov to CSREES in response to this RFA.

Prior to preparing an application, it is suggested that the PD/PI first contact an Authorized Representative (AR)(also referred to as Authorized Organizational Representative or AOR) to determine if the organization is prepared to submit electronic applications through Grant.gov. B. Content and Form of Application Submission

Electronic applications should be prepared following Part V and VI of the document entitled “A Guide for Preparation and Submission of CSREES Applications via Grants.gov.” This guide is part of the corresponding application package (see Section A. of this Part). The following is **additional information** needed in order to prepare an application in response to this RFA. If there is discrepancy between the two documents, the information contained in this RFA is overriding.

Note the attachment requirements (e.g., portable document format) in Part III section 3. of the Guide. ANY PROPOSALS CONTAINING NON-PDF DOCUMENTS WILL BE AT RISK OF BEING EXCLUDED FROM CSREES REVIEW. Partial applications will be excluded from CSREES review. With documented prior approval, resubmitted applications will be accepted until close of business on the closing date in the RFA.

This maximum (12 pages) has been established to ensure fair and equitable competition. The Project Narrative must include all of the following.

i. CYFAR Capacity Building Program Component to which you are applying (i.e., Professional Development Strategies or CYFAR Capacity Building Programs – Best Practices Dissemination Strategies)

ii. Project Staff and Lead University

Provide the name, phone number, university affiliation, street and e-mail address of the lead university faculty who will be responsible for implementing CYFAR Capacity Building objectives.

iii. Plan of Work

List each CYFAR Capacity Building Program Objective to be implemented in FY 2009 by this CYFAR Capacity Building Program component. For each objective, write a narrative plan for how that objective will be achieved, including specific tasks and timeline for execution of the tasks.

iv. Collaborators

List collaborating universities/organizations and the contact person's name, address, phone number, and e-mail address.

4. R&R Senior/Key Person Profile (Expanded)

Information related to the questions on this form is dealt with in detail in Part V, 5. of the CSREES Grants.gov Application Guide.

Current and pending support information is required only for personnel with PD or co-PD(s) indicated as Project Role on the R&R Senior/Key Person Profile. All applications must contain a list of Current and Pending Support detailing public or private support (including in-house support) to which personnel identified in the application have committed portions of their time, whether or not salary support for person(s) involved is included in the budget. **Please note that the project being proposed should be included in the pending section of the form.** Total project time listed for each PD should not exceed 100 percent for concurrent projects.

5. R&R Personal Data DO NOT PROVIDE THE SOCIAL SECURITY NUMBER OF THE PROJECT DIRECTOR/PRINCIPAL INVESTIGATOR As noted in Part V, 6. of the CSREES Grants.gov Application Guide, the submission of this information is voluntary and is not a precondition of award. If completing the information, **do not enter any data in the field requesting the social security number.**

6. R&R Budget

Applications must contain a budget and narrative for the budget period for the entire duration of the proposed project. Annual and cumulative budgets and narratives are required

7. Supplemental Information Form

Information related to the questions on this form is dealt with in detail in Part VI, 1. of the CSREES Grants.gov Application Guide.

a. Field 2. Program Code. Enter the program code name Enter the program code name “Children, Youth, and Families at-Risk Capacity Building Program” and the program code, “MC”.

b. Conflict of Interest List (Field 8. on the Form). A conflict of interest list is required under this program.

C. Submission Dates and Times

Instructions for submitting an application are included in Part IV, Section 1.9 of the CSREES Grants.gov Application Guide.

Applications must be received by Grants.gov by COB on July 27, 2009 (5:00 p.m. Eastern Time). Applications received after this deadline will normally not be considered for funding.

Correspondence regarding submitted applications will be sent using e-mail. Therefore, applicants are strongly encouraged to provide accurate e-mail addresses, where designated, on the SF-424 R&R Application for Federal Assistance.

If the AR has not received correspondence **from CSREES** regarding a submitted application within 15 days of the established deadline, please contact the Program Contact identified in Part VII of the applicable RFA and request the proposal number assigned to the application. **Failure to do so may result in (the application not being considered for funding by the peer review panel. Once the application has been assigned a proposal number, this number should be cited on all future correspondence.**

D. Funding Restrictions

Pursuant to Section 1473 of the National Agricultural Research, Extension, and Teaching Policy Act of 1977, as amended, 7 U.S.C. 3319, **indirect costs and tuition remission are not allowable costs under Section 3(d) of Smith-Lever funded projects, and no funds will be approved for this purpose.** Costs that are a part of an institution’s indirect cost pool (e.g., administrative or clerical salaries) may not be reclassified as direct costs for the purpose of making them allowable.

Grant funds awarded under this authority may not be used for the renovation or refurbishment of research, education, or Extension space; the purchase or installation of fixed equipment in such space; or the planning, repair, rehabilitation, acquisition, or construction of buildings or facilities.

E. Other Submission Requirements

The applicant should follow the submission requirements noted in the document entitled “A Guide for Preparation and Submission of CSREES Applications via Grants.gov.”

PART V—APPLICATION REVIEW REQUIREMENTS

A. General

Each application will be evaluated in a 2-part process. First, each application will be screened to ensure that it meets the administrative requirements as set forth in this RFA. Second, applications that meet these requirements will be technically evaluated by a review panel.

Reviewers will be selected based upon training and experience in relevant scientific, extension, or education fields, taking into account the following factors: (a) The level of relevant formal scientific, technical education, or extension experience of the individual, as well as the extent to which an individual is engaged in relevant research, education, or extension activities; (b) the need to include as reviewers experts from various areas of specialization within relevant scientific, education, or extension fields; (c) the need to include as reviewers other experts (e.g., producers, range or forest managers/operators, and consumers) who can assess relevance of the applications to targeted audiences and to program needs; (d) the need to include as reviewers experts from a variety of organizational types (e.g., colleges, universities, industry, state and Federal agencies, private profit and non-profit organizations) and geographic locations; (e) the need to maintain a balanced composition of reviewers with regard to minority and female representation and an equitable age distribution; and (f) the need to include reviewers who can judge the effective usefulness to producers and the general public of each application.

B. Evaluation Criteria

The evaluation criteria below will be used in reviewing applications submitted in response to this RFA:

CYFAR Capacity Building Programs- Professional Development Strategies (100 points)

1. Ability to identify and develop professional development strategies inclusive of training modules and certification programs for community and state site team members working with CYFAR audiences. This criterion assesses the ability to determine competencies and training needs. (30 points)
2. Ability to identify and develop professional development strategies inclusive of a training conference for CYFAR Liaisons and CYFERNet teams members (technology, evaluation, and programming) to work with the CYFAR community and site team members. This criterion assesses the applicant's ability to identify and development professional development strategies. (40 points)
3. Key Personnel- This criterion relates to the adequacy of the number and expertise of the key person's ability to develop and carry out the project. (30 points)

CYFAR Capacity Building Programs – Best Practices Dissemination Strategies (100 points)

1. Ability to develop a strategic communication and dissemination plan regarding evidence-based practices and programs and promising/best practices which synthesizes information, provides recommendations, highlights best practices and is inclusive of a federal collaborative

partnership. This criterion focuses on an applicant's ability to develop a strategic plan for communication and dissemination and the ability to review, synthesize, recommend and collaborate. (30 points)

2. Quality of plan to achieve outcomes of a national virtual summit with experts from land-grant institutions on targeted topics of poverty, high-risk audiences, and field expert panels. This criterion assesses the applicant's expertise and familiarity with large-scale virtual conference production. (30 points)

3. Key Personnel- This criterion relates to the adequacy of the number and expertise of the key person's ability to develop and carry out the project. (40 points)

C. Conflicts of Interest and Confidentiality

During the peer evaluation process, extreme care will be taken to prevent any actual or perceived conflicts of interest that may impact review or evaluation. For the purpose of determining conflicts of interest, the academic and administrative autonomy of an institution shall be determined by reference to the current Higher Education Directory, published by Higher Education Publications, Inc., 6400 Arlington Boulevard, Suite 648, Falls Church, Virginia 22042. Names of submitting institutions and individuals, as well as application content and peer evaluations, will be kept confidential, except to those involved in the review process, to the extent permitted by law. In addition, the identities of peer reviewers will remain confidential throughout the entire review process. Therefore, the names of the reviewers will not be released to applicants.

D. Organizational Management Information

Specific management information relating to an applicant shall be submitted on a one time basis, with updates on an as needed basis, as part of the responsibility determination prior to the award of a grant identified under this RFA, if such information has not been provided previously under this or another CSREES program. CSREES will provide copies of forms recommended for use in fulfilling these requirements as part of the prewar process. Although an applicant may be eligible based on its status as one of these entities, there are factors which may exclude an applicant from receiving Federal financial and nonfinancial assistance and benefits under this program (e.g., debarment or suspension of an individual involved or a determination that an applicant is not responsible based on submitted organizational management information).

PART VI—AWARD ADMINISTRATION

A. General

Within the limit of funds available for such purpose, the awarding official of CSREES shall make grants to those responsible, eligible applicants whose applications are judged most meritorious under the procedures set forth in this RFA. The date specified by the awarding official of CSREES as the effective date of the grant shall be no later than September 30 of the Federal fiscal year in which the project is approved for support and funds are appropriated for such purpose, unless otherwise permitted by law. It should be noted that the project need not be initiated on the grant effective date, but as soon thereafter as practical so that project goals may be attained within the funded project period. All funds granted by CSREES under this RFA shall be expended solely for the purpose for which the funds are granted in accordance with the approved application and budget, the regulations, the terms and conditions of the award, the applicable Federal cost principles, and the Department's assistance regulations (2 CFR 215, 2 CFR 220 and 3 CFR 230), and the Department's assistance regulations (parts 3015, 3019 and 3430 of 7 CFR).

B. Award Notice

The award document will provide pertinent instructions and information including, at a minimum, the following:

- (1) Legal name and address of performing organization or institution to whom the Administrator has issued an award under the terms of this request for applications;
- (2) Title of project;
- (3) Name(s) and institution(s) of PDs chosen to direct and control approved activities;
- (4) Identifying award number assigned by the Department;
- (5) Project period, specifying the amount of time the Department intends to support the project without requiring recompetition for funds;
- (6) Total amount of Departmental financial assistance approved by the Administrator during the project period;
- (7) Legal authority(ies) under which the award is issued;
- (8) Appropriate Catalog of Federal Domestic Assistance (CFDA) number;
- (9) Applicable award terms and conditions (see <http://www.csrees.usda.gov/business/awards/awardterms.html> to view CSREES award terms and conditions);

(10) Approved budget plan for categorizing allocable project funds to accomplish the stated purpose of the award; and

(11) Other information or provisions deemed necessary by CSREES to carry out its respective awarding activities or to accomplish the purpose of a particular award.

C. Administrative and National Policy Requirements

Grantees are required to submit initial grant information and annual and summary reports to CSREES' Current Research Information System (CRIS).
