

Adaptation of Socio-Ecological Model






Why a CNE Framework?

Land-Grant University/Cooperative Extension System

- Expanded Food and Nutrition Education Program, (EFNEP)
 - Began in 1969
 - Current Federal allocation - \$68 million; state leveraging is unknown
 - All states, US Territories, the District of Columbia
 - 75 institutions (1862 and 1890)



Land-Grant University/Cooperative Extension System

- Supplemental Nutrition Assistance Program Education (SNAP-Ed)
 - FNS recognized as beginning in 1992 (7 states)
 - Federal allocation \$379.1 million; State share \$379.1 million plus (2010)
 - LGU subcontract (2008: most recent data)
 - \$141.5 million
 - 48 States, some territories, the District of Columbia
 - 53 institutions








Web-based Reporting System

Local, state, and national data:	Reviewed and refined current requirements; also <ul style="list-style-type: none">•Program 5 year plan/Annual Update•Qualitative Program Impacts (optional)•Budget Sheet/Budget Justification
Semi-static system	Living system (revisit every 5 years for further developments)
Formula Grant Opportunities (FGO)	Skeleton FGO requirements

Evolution of LGU SNAP-Ed Leadership

Historically	Currently
1 person - 25% time (NPL) 	NPL, Food and Nutrition Education, part of leadership responsibilities, no specific time designation
2 people – (1 NPL, 1 National Coordinator, both part-time) ; salary and office support for the National Coordinator shared by CSREES and LGU's 	2 Associate Deans (2 University Faculty, no specific time designation) (voluntary)
1 full-time National Coordinator with office support – cost shared by CSREES and LGUs – created a Program Development Team (voluntary) 	LGU SNAP-Ed office (1 person, full-time, paid position – supported by LGUs)
	Program Development Team - FCS Leaders & Program Coordinators from each Extension Region (voluntary)



Recent Products Resulting from LGU SNAP-Ed Leadership

Priority/Product	Use/Implication
National Report	Strategic Distribution – Agencies, Nutrition Evidence Library (NEL), others... forging new relationships
Seed Grants	Peer reviewed presentations and publications; catalyst for program evaluation research; agency and other interest; adding to evidence base
Communication Strategy	Survey, environmental scan, possibly an eXtension community of practice
Legislation	Rapid and coordinated response for ECOP
Training	Cost-share webinar/upcoming “Reviews” webinar; mentoring



29 States/Territories Visited


